EPIQ WEEK DAILY CHALLENGE
OFFICIAL RULES

1. Eligibility: Satisfacts ePIQ Week Daily Challenges, (the "Contest") is open to all legal residents of the 48 contiguous United States and the District of Columbia over the age of 18 with access to the Internet and a valid email account. All employees of MH Sub I, LLC ("Sponsor"), all associated agencies and their respective affiliates, licensees or agents (collectively, "Contest Entities"), and their immediate family members (spouse, parent, child, sibling and their respective spouses) and those living in the same household of each (whether related or not), are ineligible to participate in the Contest. All applicable federal, state and local laws and regulations apply. Void where prohibited or restricted by law. Entry in the Contest constitutes your full and unconditional acceptance of these Official Rules. NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

2. Contest Period: Unless specified otherwise, the Contest entry period begins: on December 13, 2021 at 10:00 AM EST and ends at 11:00 PM EST on December 17, 2021 (the "Contest Period"). The winners will be selected from entries properly submitted and timely received during the Contest Period.

3. Contest Entry: You may enter the Contest during the Contest Period by using an APPROVED method of entry. The APPROVED method of entry is:

A. Online Entry. Watch the daily ePIQ Index video posted on Satisfacts.com's Facebook page (available at <https://www.facebook.com/Satisfacts>) or Satisfacts Education page (available at <https://www.instagram.com/satisfactseducation/>) (together, the "Post(s)") and complete the daily social media challenge ("Challenge"). All entries must follow the rules below to be eligible for each Challenge (together, "Entry Requirements"). The Contest includes the following Challenges:

A. Day One Challenge: On ePIQ's December 13th, 2021 Post, comment with your favorite quote from a football movie. Entries for the Day One Challenge must be received by 8:00 PM EST on December 13th, 2021.

B. Day Two Challenge: On December 14th, 2021, post a video celebrating your team on your community or company's Facebook or Instagram page and include hashtag #epiqcelly and tag Satisfacts on Facebook or Satisfacts Education on Instagram. Entries for the Day Two Challenge must be received by 8:00 PM EST on December 14th, 2021.

C. Day Three Challenge: On ePIQ's December 15th, 2021 Post, comment with your favorite renter review from Apartmentratings.com's community page from 2021 (available at <https://www.apartmentratings.com>). Entries for the Day Three Challenge must be received by 8:00 PM EST on December 15th, 2021.

D. Day Four Challenge: On December 16, 2021, post a photo or video of your team showing their best game face or pose on your community or company's Facebook or Instagram page and include hashtag #epiqcheer and tag Satisfacts on Facebook or Satisfacts Education on Instagram. Entries for the Day Four Challenge must be received by 8:00 PM EST on December 16, 2021.

E. Day Five Challenge: on December 17, 2021, post a photo or video of your team creatively showing you are ready to "Bring it On, Catch Some Reviews, and Celebrate ePIQ Victories in 2022" and include hashtag #epiqready and tag Satisfacts on Facebook or Satisfacts Education on Instagram. Entries for the Day Five Challenge must be received by 8:00 PM EST on December 17, 2021.

Limit one (1) entry per person per day. Multiple entrants are not permitted to share the same account. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder will be deemed to be the participant. The "authorized account holder" is the natural person assigned an email account. The potential winners may be required to show proof of being the authorized account holder.

4. Selection of Contest Winners/Odds: There will be five (5) winners in total: (one (1) winner each for the Day One Challenge, Day Two Challenge, Day Three Challenge, and Day Four Challenge) and one (1) grand prize winner for the Day Five Challenge. The winners will be chosen by a panel of judges made up of representatives of the Sponsor and Contest Entities based on the following criteria: (1) if the entry was received on the day of the corresponding Challenge, (2) if the entry completed all the Entry Requirements, and (3) if the entry was original and creative. The winner of the Day Two Challenge will be announced on December 14, 2021 no later than 11:00 PM EST. The winner of the Day Three Challenge will be announced on December 15, 2021 no later than 11:00 PM EST. The winner of the Day Four Challenge will be announced on December 16, 2021 no later than 11:00 PM EST. The grand prize winner of the Day Five Challenge will be announced on December 17, 2021 no later than 11 PM EST. The winners will be notified via email. In the event that a winner is disqualified for any reason, Sponsor may, in its sole discretion, award the applicable prize(s) to an alternate winner(s). Any return of prize notification or prize email as undeliverable will result in forfeiture of any prize(s) and an alternate winner(s) may, at Sponsor's discretion, be selected.
